which follows Intraoperative Neurophysiological Monitoring in Neurosurgery. Intracranial part I: surgery of sensorimotor areas and the posterior fossa (2006) and Intracranial part II: awake surgery and cognitive mapping (2008). The theme is the same: monitoring brain functions in order to preserve them throughout the course of treatment in tumour patients.

Many assessment systems have to do with the pathology and determine the efficacy of particular treatments, while others are geared to the patient and indicate the disease state and the impact that the treatments implemented have on his or her quality of life.

As regards most of the neurological diseases in general, and neuro-oncology in particular, there is little consensus of opinion as to which instruments should be used and which criteria should be selected in order to define clinical outcomes, inasmuch as the various specialists elaborate different types of data both for the disease and for the treatment and communicating poorly with one another. Nevertheless, while the clinical assessment systems, to be appropriate, need to be capable of measuring even minor changes in the ways in which a given disease expresses itself, which differ, for example, for head injuries, epilepsy and stroke, it is also true to say that they should all describe the physical and cognitive status of the patient and his or her ability to handle specific tasks. In neuro-oncology, very little is known about the effect of the tumour *per se* on the patient's cognitive ability, and this has a negative impact on the objectivity of the clinical assessment after chemotherapy, radiotherapy and surgery, as measured, moreover, with different specific instruments (time-specific and target-specific) according to the treatment.

There are numerous care outcome measures available. These include mortality rates, complications (of disease or of medical care), biomedical measures (e.g., results of laboratory tests and vital signs), disease-specific symptoms (severity, duration, and frequency, both physical and psychological/cognitive/emotional), quality of life (e.g., pain/discomfort, treatment side effects, mood, energy level, family and social interaction, sexual function, ability to work, and ability to keep up with routine daily activities, functional status/independence), length of stay (duration of treatment), cost of care, patient satisfaction with care rendered, and access to care. Outcome quality improvement programs involve similar steps: collaborative teams, setting time-specific and measurable aims and quantitative measures. At the same time, no matter what quality measures are used, a number of complex methodological issues need to be resolved.

For these reasons, the discussion about clinical outcome measures will focus upon the wider context of central nervous system diseases, and specifically on cognitive issues.

In this symposium the following topics will be addressed:

- a) Clinical tools for outcome assessment in neuro-oncology
- b) Neuropsychological baseline cognitive assessment
- c) Current clinical outcome measures after treatment
- d) State of the art in other neurological diseases

The meeting will provide lectures, round-tables, and free papers, in the fascinating environment of Verona, with its warm, historical atmosphere

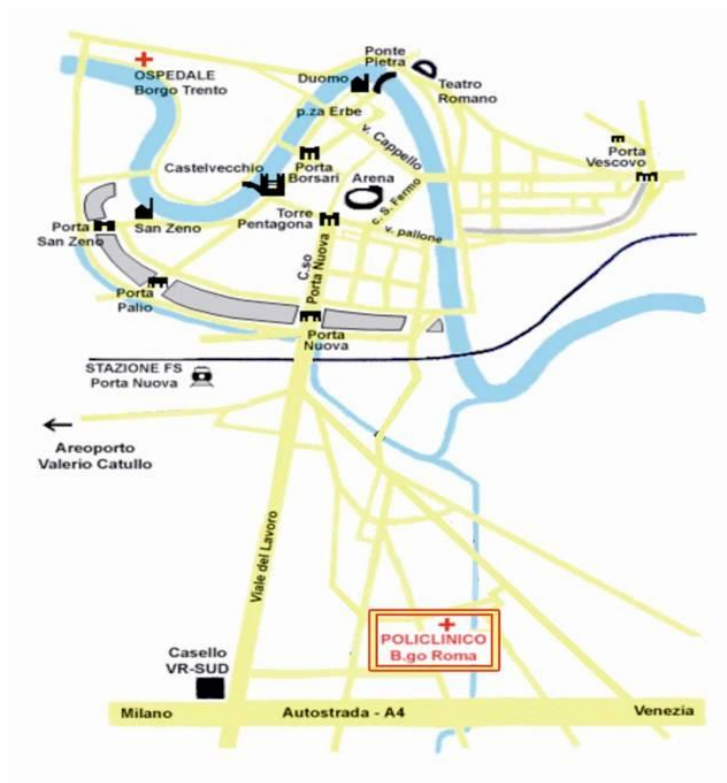
MEETING VENUE
